1. Modernisation theories (Beck, U., Wagner, P. and others). The position of social work from the aspect of Beck's reflexive modernity and Wagner's second crisis of modernity.
2. Social exclusion theory. Social work in the context of the development of social exclusion from an individual phenomenon to a mass problem.
3. Transformations of the social issue (Castel, R.) Possibilities and limits of social work as a tool for the inclusion of socially excluded persons and groups in society.
4. Theories of justification (Boltanski, L., Thévenot, L.). Different ways of legitimisation of social work and conflicts between them. The tension between mission, economic efficiency and civil law concept.
5. The institutional programme and its crisis (Dubet, F.). The classical concept of "working with people" and the risks of deprofessionalisation of social work.

5. Multi-paradigm nature of contemporary social sciences, rationale, definition criteria of individual paradigms.
6. Principles distinguishing qualitative from quantitative research. Possibilities and limits of strategies, evaluation criteria. Theoretical (paradigmatic) framework for the choice of research approach.
7. Qualitative and quantitative research as a way to understand the studied social phenomena in the action field of social work. Analytical-inductive, hypothetico-deductive and abductive model.
8. Basic approaches in qualitative research in social work. Ethical aspects of qualitative research.
9. Qualitative research design (research project). Research area, topic, research questions in qualitative research. Conceptual framework, role of theory in qualitative research.
10. Methods of collection, processing and analysis of qualitative/quantitative data. Methods of creating a research population sample in qualitative/quantitative research. Concept of validity, reliability, and objectivity in qualitative/quantitative research, criteria and methods of their ensuring.
